WISCONSIN RENTAL ASSISTANCE PROGRAM

The Wisconsin Rental Assistance Program assists eligible renters who have had a significant loss of income due to the COVID-19 pandemic and need help with their rent.



In general, eligible applicants must be an adult Wisconsin resident with a household income at or below 80% of the county median income in the month of or prior to the application date.



Eligible costs include:

- Direct financial assistance for owed rent
- Security deposits



The Rental Assistance Program can award up to \$3,000 per household in a combination of rental payments and/or security deposits.The payment is paid directly to the landlord.
